4 FOR the purpose of requiring certain county boards of education to develop and adopt a
5 policy ~~that prohibits elementary and middle school students from using a cellular~~
6 ~~phone or~~ on the use of a personal electronic device during ~~the school day except under~~
7 ~~certain circumstances;~~ school hours; requiring that the policy limit the use of a
8 smartphone and a device connected to a smartphone during instructional time,
9 except under certain circumstances; and generally relating to county boards of
10 education and a student technology use policy ~~for elementary and middle schools~~

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

(A) IN THIS SECTION, "PERSONAL ELECTRONIC DEVICE" MEANS ANY PORTABLE ELECTRONIC DEVICE FOR INDIVIDUAL USE, INCLUDING A SMARTPHONE, TABLET, LAPTOP, ~~OR SMARTWATCH, OR SMARTGLASSES.~~

(B) THIS SECTION DOES NOT APPLY TO A COUNTY BOARD THAT HAS AN EXISTING POLICY ~~LIMITING THE USE OF CELLULAR PHONES AND~~ ON THE USE OF PERSONAL ELECTRONIC DEVICES BY STUDENTS IN ELEMENTARY AND MIDDLE SCHOOLS DURING SCHOOL HOURS DURING SCHOOL HOURS THAT INCLUDES A LIMITATION ON THE USE OF A SMARTPHONE OR A DEVICE CONNECTED TO A SMARTPHONE DURING INSTRUCTIONAL TIME.

(C) (1) EACH COUNTY BOARD SHALL DEVELOP AND ADOPT A POLICY ~~THAT PROHIBITS AN ELEMENTARY SCHOOL OR A MIDDLE SCHOOL STUDENT FROM USING A CELLULAR PHONE OR PERSONAL ELECTRONIC DEVICE DURING SCHOOL HOURS~~ ON THE USE OF PERSONAL ELECTRONIC DEVICES DURING SCHOOL HOURS.

(2) EXCEPT AS PROVIDED UNDER SUBSECTION (D) OF THIS SECTION, THE POLICY SHALL INCLUDE A LIMITATION ON THE USE OF A SMARTPHONE OR A DEVICE CONNECTED TO A SMARTPHONE DURING INSTRUCTIONAL TIME.

(D) A POLICY DEVELOPED UNDER THIS SECTION MAY NOT PROHIBIT A STUDENT FROM USING A ~~CELLULAR PHONE OR PERSONAL ELECTRONIC DEVICE~~ SMARTPHONE OR A DEVICE CONNECTED TO A SMARTPHONE:

(1) FOR ANY PURPOSE DOCUMENTED IN THE STUDENT'S INDIVIDUALIZED EDUCATION PROGRAM OR SECTION 504 PLAN;

(2) TO MONITOR OR ADDRESS A STUDENT'S DOCUMENTED HEALTH ISSUE; OR

(3) WHEN DIRECTED BY AN EDUCATOR OR ADMINISTRATOR FOR EDUCATIONAL PURPOSES.

(E) A POLICY ADOPTED IN ACCORDANCE WITH THIS SECTION SHALL BE PUBLISHED:

(1) ON THE WEBSITE OF EACH COUNTY BOARD; AND

(2) IN EACH PUBLIC SCHOOL STUDENT HANDBOOK.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025.
