Public Safety - <u>Fuel Gas Piping Systems and</u> Corrugated Stainless Steel Tubing <u>for Fuel Gas Piping Systems- Requirements and Prohibitions</u> - <u>Prohibitions</u> <u>and Study</u>

 $\mathbf{5}$ FOR the purpose of prohibiting the sale, offer for sale, transfer, or distribution of 6 non-arc-resistant jacketed corrugated stainless steel tubing that does not meet 7 certain qualifications; requiring certain tubing used; establishing a certain civil 8 penalty for a person who uses certain tubing in the construction of fuel gas piping 9 systems in certain buildings to meet certain qualifications; requiring the Maryland 10 Department of Labor and the Office of the State Fire Marshal to study and make recommendations related to preventing the fire hazards associated with commonly 11 used fuel gas piping systems, including gas piping and corrugated stainless steel 1213tubing, in residential and commercial buildings; and generally relating to fuel gas 14 piping systems, gas piping, and corrugated stainless steel tubing.
