A BILL ENTITLED

1 AN ACT concerning

2 **Prostate Cancer Care Access Grant Program and Fund – Establishment**

3 FOR the purpose of establishing the Prostate Cancer Care Access Grant Program to provide
4 grants to improve awareness of and access to prostate cancer care services for
5 individuals in the State; establishing the Prostate Cancer Care Access Grant
6 Program Fund as a special, nonlapsing fund to provide grants under the Program;
7 requiring that interest earned by the Fund be credited to the Fund; and generally
8 relating to the Prostate Cancer Care Access Grant Program and Fund.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Health – General

SUBTITLE 55. PROSTATE CANCER CARE ACCESS GRANT PROGRAM.

13–5501.

(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
INDICATED.

(B) “FUND” MEANS THE PROSTATE CANCER CARE ACCESS GRANT
PROGRAM FUND.

(C) “PROGRAM” MEANS THE PROSTATE CANCER CARE ACCESS GRANT
PROGRAM.

13–5502.

(A) THERE IS A PROSTATE CANCER CARE ACCESS GRANT PROGRAM.

(B) THE PURPOSE OF THE PROGRAM IS TO PROVIDE GRANTS TO IMPROVE
AWARENESS OF AND ACCESS TO PROSTATE CANCER CARE SERVICES FOR
INDIVIDUALS IN THE STATE.

(C) THE SECRETARY SHALL PROVIDE GRANTS TO SUPPORT:

(1) ENTITIES AND PROSTATE CANCER CARE PROVIDERS TO
INCREASE THE GENERAL PUBLIC’S KNOWLEDGE AND AWARENESS OF PROSTATE
CANCER;

(2) TRAVEL AND RELATED COSTS FOR INDIVIDUALS WHO ARE
UNABLE TO ACCESS PROSTATE CANCER CARE IN THEIR OWN COMMUNITIES; AND

(3) ANY OTHER INITIATIVE TO IMPROVE ACCESS TO PROSTATE
CANCER CARE AS DETERMINED BY THE SECRETARY IN CONSULTATION WITH
ORGANIZATIONS THAT HAVE A FOCUS ON INCREASING ACCESS TO CULTURALLY
COMPETENT PROSTATE CANCER CARE.

1 (A) **THERE IS A PROSTATE CANCER CARE ACCESS GRANT PROGRAM FUND.**

2 (B) **THE PURPOSE OF THE FUND IS TO PROVIDE GRANTS UNDER THE**
3 **PROGRAM.**

4 (C) **THE SECRETARY SHALL ADMINISTER THE FUND.**

5 (D) **(1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT**
6 **SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

7 **(2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,**
8 **AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

9 (E) **THE FUND CONSISTS OF:**

10 **(1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;**

11 **(2) INTEREST EARNINGS OF THE FUND; AND**

12 **(3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
13 **THE BENEFIT OF THE FUND.**

14 (F) **THE FUND MAY BE USED ONLY FOR THE PROGRAM.**

15 (G) **(1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
16 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

17 **(2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO**
18 **THE FUND.**

19 (H) **EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE**
20 **WITH THE STATE BUDGET.**

22 (A) **ON OR BEFORE OCTOBER 1, 2025, THE GOVERNOR SHALL ALLOCATE BY**
23 **BUDGET AMENDMENT AT LEAST \$100,000 OF THE FUND FOR THE PROGRAM FOR**
24 **FISCAL YEAR 2026.**

25 (B) **FOR EACH OF FISCAL YEARS 2027 AND 2028, THE GOVERNOR SHALL**
26 **INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$100,000 FOR THE**
27 **PROGRAM.**

Article – State Finance and Procurement

6–226.

(a) (2) (i) 1. This subparagraph does not apply in fiscal years 2024 through 2028.

2. Notwithstanding any other provision of law, and unless inconsistent with a federal law, grant agreement, or other federal requirement or with the terms of a gift or settlement agreement, net interest on all State money allocated by the State Treasurer under this section to special funds or accounts, and otherwise entitled to receive interest earnings, as accounted for by the Comptroller, shall accrue to the General Fund of the State.

(ii) The provisions of subparagraph (i) of this paragraph do not apply to the following funds:

204. the Victims of Domestic Violence Program Grant Fund;
[and]

205. the Proposed Programs Collaborative Grant Fund; AND

206. THE PROSTATE CANCER CARE ACCESS GRANT PROGRAM FUND.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2025.
